

RESOLUTION NO. 2019-042

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK AUTHORIZING AND APPROVING A FIVE-YEAR CONTRACT WITH AXON ENTERPRISES, INC. FOR BODY WORN CAMERAS, CONDUCTED ELECTRICAL DEVICES (TASER®), AND DIGITAL MEDIA STORAGE (EVIDENCE.COM) NOT TO EXCEED \$725,000 AND AUTHORIZING THE FINANCE DIRECTOR TO INCREASE APPROPRIATIONS IN FY 2018-19 BY \$130,000 FROM THE STATE ASSET FORFEITURE FUND

WHEREAS; the Public Safety Department issues body worn cameras manufactured by Vie Vu that has been purchased by Axon Enterprise, Inc.; and,

WHEREAS; the Public Safety Department issues conducted electrical devices (Taser®) manufactured by Taser International that has been purchased by Axon Enterprise, Inc.; and,

WHEREAS; the Public Safety Department uses local storage to manage all electronic evidence; and,

WHEREAS; both the cameras and the Tasers have reached their end of life usage and are no longer covered under warranty; and,

WHEREAS; AB748 subjects to public disclosure audio and video of critical incidents, which may require redaction, and the process of manual redaction is costly and time consuming; and,

WHEREAS; redaction will require updating hardware and software; and,

WHEREAS, the State Asset Forfeiture Fund has fund balance to cover year one (\$130,000) of a five year (\$725,000 excluding discounts) contract with Axon Enterprise Inc. to issue new cameras, conducted electrical devices and enrollment in "Evidence.com", an electronic evidence management system; and,

WHEREAS, the proposed contract is exempt from bidding in accordance with the City's Purchasing Policy section 7.1, covering software licenses and subscriptions, and section 7.2, covering sole source purchases directly from a manufacturer, purchases where a certain product is the only one proven acceptable or compatible with existing equipment.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park that it does hereby authorize and approve the Master Services and Purchasing Agreement with Axon Enterprises, Inc., for purchase of cameras, conducted electrical devices and Evidence.com software services; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute documents pertaining to same for and on behalf of the City of Rohnert Park; and

BE IT FURTHER RESOLVED that the Finance Director is authorized to increase appropriations in FY 2018-19 by \$130,000 from the State Asset Forfeiture Fund to fund year one of a five year contract with Axon Enterprises, Inc. for body worn cameras, conducted electrical devices (Taser®), and digital media storage, and to record the transaction in accordance with Generally Accepted Accounting Principles (GAAP).
