The maintenance inspection on the South and North Courses occurred on March 27th 2023

## SOUTH COURSE

## 1. GENERAL OBSERVATIONS:

The overall appearance for the South Course is fair for Spring. The recent on and off again storms have taken its toll on the normal day to day maintenance leaving the grasses long and the bunkers fill of water.

There are still remnants of fallen trees along the Smart Train path and Hole #10 left from previous report.

Overall Rating: fair

## Cart Paths

Cart paths (concrete infrastructure) are in poor condition. Cart paths need to be edged and debris removed. Small patches of debris are throughout the course from puddles and mud.

Rating: poor

#### <u>Fairways</u>

Fairways are green with wet spots and puddles. The little white flowers throughout the fairways are getting more abundant should be sprayed.

Rating: Fair

## <u>Greens</u>

The greens are firm and appropriately cut.

Rating: Good

#### **Bunkers**

The bunkers (sand traps) are in poor condition; they need to be edged and weeded after the rains.

Rating: Poor

## **Out-of-Play Areas**

The out-of-play areas are slowing filling in with weeds and look green in color. Rating: Fair

## Maintenance Credit Area (along Golf Course Dr.)

The maintenance credit area is mostly green and needs to be mowed.

The curb, tree wells and signs need to be weeded and or edged.

Rating: Fair

#### Pro Shop

The Pro Shop has a new layout with and new colors throughout. It looks amazing.

#### AREAS IN NEED OF IMPROVEMENT (noted in previous report):

- Tree wells need to be weeded. Some have been completed
- Tree limbs raised . *Most have been completed*
- Weeds in cart paths need to be weeded. Weeds have been removed

## **RECENT IMPROVEMENTS**

• Pro Shop has been redesigned and painted

## 3. AREAS IN NEED OF IMPROVEMENT (Spring 2023):

- Overall the course could use some clean up after the storms.
- Bunkers and cart paths need a lot of attention. There are still remnants of fallen trees that need to be removed. Hole #4, #6, and Hole #10.
- Grass needs to be mowed and
- Bunkers could need a lot of work.

#### **NORTH COURSE**

#### **1. GENERAL OBSERVATIONS:**

The overall appearance for the North Course is good. The fairway turf is green with very little sparse areas. The natural habitat could use a mow soon. Sand bunkers looked like they can use some maintenance, except the bunkers that have already been renovated. They look amazing.

Overall Rating: Good

#### **Cart Paths**

Cart paths looked good. Repairs have been made on Hole 11. And look great.

More cart paths to be repaired after July (\$20k)

Rating: Fair

## <u>Fairways</u>

The fairways appear to be in good condition. Grass was long, but was being mowed at the time of the report.

Rating: Fair

## **Greens**

The greens continue to look good. The turf is green, healthy, nicely cut and free from discolorations.

Rating: Very Good

#### **Bunkers**

Bunkers are being renovated as we speak, however the ones that they haven't got to yet look bad and can use some attention.

Rating: Fair

## **Out-of-Play Areas**

The natural habitat areas look good but will need to be mowed soon.

Rating: Fair

## 2. AREAS IN NEED OF IMPROVEMENT (noted in previous report):

- Weeds in the cart paths need to be removed. Completed
- Natural Habitat needs to be mowed. *Has been completed but with the sun and rain followed by more sun and rain. The grass is growing fast and it could use a mow soon.*

## **3. RECENT IMPROVEMENTS:**


- Overall the North Course looks fair.






