#### **CONTRACTORS ONLY**

- A copy of your recent Contractor's License shall be submitted with your application.
- You must maintain a valid Worker's Compensation Insurance, and provide recent proof of valid insurance.
- An Annual City of Rohnert Park License needs to be obtained prior to applying and getting a building permit issued. (A One Job Only application will not be accepted for online access)
  - Should the Worker's Compensation Insurance and/or Contractor's License or Rohnert Park City
     Business License be terminated, suspended, or revoked, then the Applicant shall immediately
     cease any and all work and notify the City of Rohnert Park Building Division.

#### **ALL APPLICANTS**

Complete and sign the application for an account for electronic building permit issuance.
 Upon completion of the application, a password will be issued to the Applicant that shall only be used by the Applicant. Upon initial use of the password you will be prompted to change it for security purposes and then you'll be able to start utilizing the online-permitting system.
