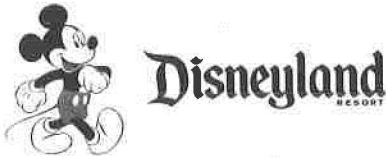

By this letter, we are notifying you of the 1-Day Park Hopper Tickets to the Disneyland Resort that were provided by The Walt Disney Company to Rohnert Park DPS FD. In accordance with state law and Rohnert Park DPS FD's policy for acceptance of payments from third parties, The Walt Disney Company has not designated by name, title, class, or otherwise any officials who will use the payments, but instead these details will be controlled by Rohnert Park DPS FD and used for official business. These payments are not considered a reportable or limited gift to any individual public officer, but do require disclosure on Forms 801 (within 30 days) and 802 (within 45 days) by Rohnert Park DPS FD following acceptance of the tickets.
