WHEREAS, the Rohnert Park City Council does hereby find that the aforesaid conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency; and

WHEREAS, the Director of Emergency Services of the City of Rohnert Park did proclaim the existence of a local emergency within said city on the 9th day of October, 2017;

NOW, THEREFORE, BE IT RESOLVED that said proclamation of existence of a local emergency, as issued by said City Manager/Emergency Services Director, is hereby ratified by the Rohnert Park City Council; and

BE IT FURTHER RESOLVED that said local emergency shall be deemed to continue to exist until its termination is proclaimed by the City Council of the City of Rohnert Park, Sonoma County, California.

PROCLAMATION

A PROCLAMATION BY THE DIRECTOR OF EMERGENCY SERVICES OF THE **CITY OF ROHNERT PARK DECLARING THE EXISTENCE OF A LOCAL EMERGENCY**

NOW, THEREFORE, the Director of Emergency Services finds that:

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that a local emergency exists in accordance with the findings set forth above.

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of this local emergency, the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law and by ordinances, resolutions, and orders of this City.

IT IS FURTHER PROCLAIMED AND ORDERED that this local emergency shall continue to exist until the City Council proclaims the termination of this local emergency. The City Council shall, at its next regularly scheduled meeting, or within 21 days of this proclamation, whichever first occurs, determine whether to continue the local emergency. The City Council shall terminate the local emergency at the earliest possible date that conditions warrant.
