RESOLUTION NO. 2018-095

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK CALLING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 6, 2018 FOR THE ELECTION OF CERTAIN OFFICERS AND REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SONOMA TO CONSOLIDATE SAID ELECTION PURSUANT TO § 10403 OF THE ELECTIONS CODE

WHEREAS, under the provisions of the law relating to general law cities in the State of California, a General Municipal Election shall be held on November 6, 2018, for the purpose of the election of two (2) Members of the City Council, for a term of four (4) years, with said terms to expire in December of the year 2022, and;

WHEREAS, The City's General Municipal Election will be held and conducted in accordance with the provisions of law regulating the statewide or special election, and;

WHEREAS, it is desirable that the General Municipal Election be consolidated with the Statewide General Election to be held on the same date, and that the county elections department of the County of Sonoma canvass the returns of the General Municipal Election.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Rohnert Park does hereby resolve, declare, determine and order as follows:

- **SECTION 1.** That pursuant to the requirements of the laws of the State of California relating to General Law Cities, a general municipal election is called and ordered to be held in the City of Rohnert Park, California, on Tuesday, November 6, 2018, for the purpose of electing two (2) members to the City Council for the full term of four (4) years.
- **SECTION 2.** That the county election department is authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used. The election will be held and conducted in accordance with the provisions of law regulating the statewide or special election.
- SECTION 3. That pursuant to the requirements of § 10403 of the Elections Code, the Sonoma County Board of Supervisors is hereby requested to consent and agree to the consolidation of a General Municipal Election with the Statewide General Election and pursuant to § 10002 permit the Sonoma County Registrar of Voters Office to prepare all required notices and election materials of holding of the general municipal election, give all such required notices and send to the City's registered voters all required election materials, conduct the general municipal election and canvass the vote received, and take all steps necessary and required for the holding of this election within the City of Rohnert Park.

SECTION 4. That the City of Rohnert Park recognizes that additional costs will be incurred by the County by reason of this consolidation and agrees to reimburse the County for such costs.

SECTION 5. That the City Clerk is directed to transmit a certified copy of this resolution to the Sonoma County Board of Supervisors at the Sonoma County Registrar of Voters.

SECTION 6. That the City of Rohnert Park declares that the nominations for the general municipal election shall open on July 16, 2018 and close no later than 5:00 p.m. August 10, 2018, unless extended pursuant to Elections Code § 10225.

SECTION 7. That notice of the time and place of holding these elections within the City of Rohnert Park for the General Municipal Election is hereby authorized and approved and the City Clerk is authorized, instructed, and directed to give further or additional notice of the election in the time, form and manner as required by law.
