

RESOLUTION NO. 2012-25

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK ADOPTING THE PLAN 'TAMING NATURAL DISASTERS' AS THE CITY OF ROHNERT PARK'S LOCAL HAZARD MITIGATION PLAN

WHEREAS, the Bay Area is subject to various earthquake-related hazards such as ground shaking, liquefaction, landsliding, fault surface rupture, and tsunamis; and

WHEREAS, the Bay Area is subject to various weather-related hazards including wildfires, floods, and landslides; and

WHEREAS, the City of Rohnert Park recognizes that disasters do not recognize city, county, or special district boundaries; and

WHEREAS, the City of Rohnert Park seeks to maintain and enhance both a disaster resistant Rohnert Park and region by reducing the potential loss of life, property damage, and environmental degradation from natural disasters, while accelerating economic recovery from those disasters; and

WHEREAS, the City of Rohnert Park is committed to increasing the disaster resistance of the infrastructure, health, housing, economy, government services, education, environment, and land use systems in the City of Rohnert Park, as well as in the Bay Area as a whole; and

WHEREAS, the federal Disaster Mitigation Act of 2000 (Act) requires all cities, counties, and special districts to adopt a Local Hazard Mitigation Plan to receive disaster mitigation funding from FEMA; and

WHEREAS, ABAG has approved and adopted the ABAG report Taming Natural Disasters, created in collaboration with the participating jurisdictions, as the multijurisdictional Local Hazard Mitigation Plan for the San Francisco Bay Area;

NOW, THEREFORE, BE IT RESOLVED that the City of Rohnert Park adopts, and adapts with its local annex, this multi-jurisdictional plan as its Local Hazard Mitigation Plan.

BE IT FURTHER RESOLVED that the City of Rohnert Park commits to continuing to take those actions and initiating further actions, as appropriate which are identified in the Rohnert Park Annex of that multi-jurisdictional Local Hazard Mitigation Plan.
