

**RESOLUTION NO. 2012-26**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK  
ACCEPTING THE GRANT FOR ONE ELECTRIC VEHICLE CHARGING STATION  
AND APPROVING THE CHARGEPOINT CALIFORNIA STATION AWARD  
AGREEMENT AND THE COULOMB MASTER SERVICES SUBSCRIPTION  
AGREEMENT**

**WHEREAS**, the City of Rohnert Park is invited by the County of Sonoma to participate in the Coulomb ChargePoint America Grant program as the recipient of one (1) electric vehicle (EV) charging station to be installed at the City Center Plaza parking lot; and

**WHEREAS**, by accepting the grants, the City of Rohnert Park is required to enter into 1) ChargePoint California Station Award Agreement and 2) a two-year Coulomb's Master Services Subscription Agreement; and

**WHEREAS**, the City of Rohnert Park is required by the terms of the agreement to maintain and operate the charging stations for a 2-year term; and

**WHEREAS**, the City of Rohnert Park is required by the terms of the agreement to pay Coulomb all user fees during the two-year operation of the charging stations; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Rohnert Park that it does hereby accept the grant for the one electric vehicle charging station and approve the 1) ChargePoint California Station Award Agreement and 2) the Coulomb Master Services Subscription Agreement; and

**BE IT FURTHER RESOLVED** that the adoption of this resolution is exempt from CEQA pursuant to CEQA Guidelines sections 15273, 15303, 15304, and 15311 for the reasons set forth in the staff report, which are hereby incorporated by this reference; and

**BE IT FURTHER RESOLVED** that the City Manager is hereby authorized and directed to execute these contracts in substantially similar form to the attached contracts for and on behalf of the City of Rohnert Park.
