## **RESOLUTION NO. 2012-64**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK ADOPTING REGULATIONS FOR CANDIDATES FOR ELECTIVE OFFICE PERTAINING TO CANDIDATES' STATEMENTS SUBMITTED TO THE VOTERS AT AN ELECTION TO BE HELD ON NOVEMBER 6, 2012

WHEREAS, the City will be holding a General Municipal Election on Tuesday, November 6, 2012, for the purpose of electing three (3) City Council Members; and

WHEREAS, § 13307 of the Elections Code of the State of California provides that the governing body of any local agency adopt regulations pertaining to materials prepared by any candidate for a municipal election, including costs of the candidate's statement.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Rohnert Park does hereby resolve, declare, determine and order as follows:

**SECTION 1.** Each candidate for elective office may prepare a candidate's statement on an appropriate form provided by the City Clerk.

**SECTION 2.** Elections Code § 13307 requires that, if the candidate wishes to file a candidate statement, it shall be filed in the office of the elections official no later than the 88<sup>th</sup> day before the election. Therefore, the candidate shall file the candidate's statement no later than 5:00 p.m. on August 10, 2012, unless extended pursuant to Elections Code § 10225, which is the 88<sup>th</sup> day prior to the general municipal election.

**SECTION 3.** The statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination period.

**SECTION 3.** The candidate's statement may include the name, age (optional), and occupation of the candidate and a brief description of no more than 200 words describing the candidate's education and qualifications expressed by the candidate himself or herself.

**SECTION 4.** The statement shall not include party affiliation of the candidate, nor membership or activity in partian political organizations.

**SECTION 5.** The candidate shall not be required to pay for the cost of printing the candidate's statement in English.

**SECTION 6.** The candidate shall be required to pay for the cost of printing the candidate's statement into any foreign language, as specified pursuant to State and/or Federal law, and shall pay the estimated cost in advance at the time of the filing of nomination papers.

**SECTION 7.** The City Clerk shall provide each candidate a copy of this Resolution at the time nomination petitions are issued.

**SECTION 8.** This Resolution shall apply at the general municipal election to be held within the City of Rohnert Park on Tuesday, November 6, 2012.
