A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK AUTHORIZING AND APPROVING THE PURCHASE OF NEW TYPE 1 FIRE ENGINE FOR THE DEPARTMENT OF PUBLC SAFETY

WHEREAS, the City of Rohnert Park Municipal Code Title 3 Chapter 3.04 provides that the City's purchasing functions shall be governed by the City's purchasing policy, and;

WHEREAS, the Department of Public Safety is proposing the purchase of a new Pierce Manufactured Type 1 Fire Engine. This engine will be built on a commercial manufactured Freightliner chassis. The new chassis will have a more efficient and cleaner burning diesel engine, and;

WHEREAS, as per the City Ordinance 843, Resolution 2012-22 this Pierce Manufacturing Type 1 Fire Engine is available for purchase through a Cooperative Purchase Agreement with Dobbins Oregon Fire Department as per Contract # 71128-11 to Golden State Fire Apparatus Inc., of Modesto, CA, and;

WHEREAS, staff recommends authorizing the purchase for a Type 1 Fire Engine to Golden State Fire Apparatus, Inc., of Modesto, California in the amount of \$249,392.85, and;

WHEREAS, the purchase of the new fire engine will be fully funded July 1, 2013, as per the Sonoma Mountain Village, LLC, Development Agreement, Second Amendment dated December 2, 2012. Said Amendment provides the City with a Public Safety Response Contribution of Three Hundred Thousand Dollars (\$300,000), and;

WHEREAS, the City Council considered this Resolution at its duly noticed regular meeting on March 12, 2013 along with the staff report, presentation and public comment, and;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park that it does hereby authorize and approve the purchase of a Type 1 Fire Engine from the following authorized vendor,
