

## **RESOLUTION NO. 2013-051**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK APPROVING AUTHORIZING AND APPROVING THE PURCHASE OF EXERCISE EQUIPMENT FROM TECHNOGYM, USA AT THE CALLINAN SPORTS AND FITNESS CENTER AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO A PURCHASE AGREEMENT AND FINANCING AGREEMENT FOR THE EQUIPMENT**

**WHEREAS**, much of the existing cardio exercise equipment at the Callinan Sports & Fitness Center, has outlived its life-expectancy, is outdated technology, and is in need of replacement, and

**WHEREAS**, it is necessary to stay current with the quality and technology of our exercise equipment in order to be competitive with other local health clubs, to retain our existing members and attract new participants, and

**WHEREAS**, pursuant to Rohnert Park Municipal Code Section 3.04 (Purchasing Program) and Chapter 5.1.1 and Chapter 7.1 of the City Council Purchasing Policy, the City prepared a Request for Proposal and sent it to nine (9) major equipment suppliers.

**WHEREAS**, the City received seven (7) proposals, which were evaluated using the following criterion: total cost of equipment, financing options, quality of equipment, value and variety of features, ease of installation, technical and maintenance support and team experience.

**WHEREAS**, an evaluation committee selected Technogym USA as the preferred supplier based upon the evaluation criterion.

**WHEREAS**, it is the desire of the City to authorize the purchase of the exercise equipment and to direct the City Manager to negotiate and enter into (1) a purchase agreement with Technogym, USA for the equipment and (2) a financing agreement to amortize the costs of the purchase price over a five-year period and provide repair and maintenance services for the life of the agreement

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Rohnert Park that it does hereby authorize and approve the purchase of cardio exercise equipment in the amount of \$151,053.30 plus sales tax, from Technogym, USA.

**BE IT FURTHER RESOLVED** that the City Manager is hereby authorized and directed to negotiate and enter into (1) a purchase agreement with Technogym, USA for the equipment, and (2) a lease agreement with California First National Bank to finance this purchase for a period of 60 months at a monthly payment of \$2,805.06. Both agreements shall be subject to review and modification by the City Attorney. The City Manager is further authorized to execute documents pertaining to the cardio exercise equipment purchase for and on behalf of the City of Rohnert Park.
