RESOLUTION NO. 2013-160

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION CONSOLIDATED WITH THE CONSOLIDATED ELECTIONS HELD ON NOVEMBER 5, 2013, DECLARING RESULTS AND SUCH OTHER MATTER AS PROVIDED BY LAW

WHEREAS, a Special Municipal Election Consolidated with the Consolidated Elections was held and conducted in the City of Rohnert Park on Tuesday, November 5, 2013, as required by law; and

WHEREAS, Resolution 2013-114 1) called an election to ask the voters of the City of Rohnert Park to approve the continuation of an existing general transactions and use tax of one-half cent; 2) approved the form of the ordinance to be submitted to the voters; 3) requested that the Board of Supervisors of the County of Sonoma consolidate the election with the established election to be held on November 5, 2013; 4) authorized the Board of Supervisors of the County of Sonoma to canvas the returns and certify the results; and 5) directed the County Elections Department to conduct the election on the City's behalf; and

WHEREAS, it appears that notice of said election was duly and legally given, that voting precincts were properly established, that election officers were appointed and election supplies furnished, that in all respects said election was held and conducted and the votes cast thereat received and canvassed and the returns thereof made, determined and declared in the time, form and manner as required by the General Laws of the State providing for and regulating municipal elections in said City; and

WHEREAS, the County Elections Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit A; and

WHEREAS, the City Council of the City of Rohnert Park met at the regular meeting place of said City Council for a regular meeting on Tuesday, November 26, 2013 to declare the results pursuant to Elections Code §15400 incorporating the "Statement of Results" of said election in Exhibit A.

BE IT RESOLVED by the City Council of the City of Rohnert Park, Sonoma County, California, declares as follows:

1. That a canvass of the votes east in the November 5, 2013, Municipal Election Consolidated with the Consolidated Elections for Measure A, Rohnert Park Continuation of Essential City Services Funding, was duly performed by the Office of the Sonoma County Clerk and Registrar of Voters. The transmittal for same constituting certification of the Official Canvass for adoption by the governing body of the City of Rohnert Park was received by the City on November 14, 2013.

- 2. That the whole number of votes (ballots) cast in the precincts was 1000 and the whole number of vote by mail voter ballots cast was 5226 making a total of 6,226 votes (ballots) cast in the City.
- 3. That the special municipal election was held for the purpose of submitting to the voters of the City, Measure A, Rohnert Park Continuation of Essential City Services Funding Measure, to determine whether it should be passed, the following question:

Rohnert Park Continuation of Essential Services Funding Measure. To preserve the safety and character of Rohnert Park, and maintain/protect general City services, including 9-1-1 emergency response; fire protection; neighborhood police patrols; gang/sex offender	YES[]
enforcement; disaster preparedness; street paving/pothole repair; park maintenance; and other essential services, shall the City of Rohnert Park continue a voter-approved ½ cent sales tax, subject to annual audits and public review, keeping money from Sacramento, and without raising existing tax rates?	NO[]

- 4. That the number of votes given at each precinct and the number of votes given in the City for and against the question are attached as **Exhibit A**, "Statement of Results."
- 5. The City Council does declare and determine that:

As a result of the election, a majority of the voters voting on Measure A (Yes $\underline{4,187}$ and No $\underline{2,033}$) did vote in favor thereof, and that the City of Rohnert Park shall continue a voter-approved $\frac{1}{2}$ cent sales tax.

- 6. The City Clerk shall enter on the Minutes of the City Council of the City of Rohnert Park, a statement of the results of the election showing: 1) the whole number of votes cast in the City; 2) the measure voted upon; 3) the number of votes given at each precinct for and against the measure; and 4) the total number of votes for and against the measure.
- 7. That the City Clerk is hereby ordered to certify to the adoption of this resolution and enter it into the book of original resolutions.
