

## **RESOLUTION NO. 2014-097**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK AUTHORIZING THE PURCHASE OF EIGHT (8) PUBLIC WORKS UTILITY TRUCKS AND SPECIALTY TRUCK MOUNTED EQUIPMENT NOT TO EXCEED \$310,000**

**WHEREAS**, the City of Rohnert Park Municipal Code Title 3 Chapter 3.04 provides that the City's purchasing functions shall be governed by the City's purchasing policy, and;

**WHEREAS**, the Public Works Department, has budgeted in fiscal year 2014/2015 for the purchase of eight (8) new utility trucks, and;

**WHEREAS**, as per the City Ordinance 843, Resolution 2012-22 these vehicles are available for purchase through a Cooperative Purchase Agreement with the State of California Multiple Award Schedule as per Contract #1-14-23-20A and #1-14-23-23A from Downtown Ford of Sacramento, California.

**WHEREAS**, the total cost for the eight (8) utility trucks is \$238,170.57, and;

**WHEREAS**, per the City Ordinance 843, Resolution 2012-22 the purchase of one (1) specialized truck mounted loader is available through Nixon-Egle Equipment Co. of Tracy, CA by means of a Sole Source Purchase. Said vendor is the only authorized distributor in Northern California, the specialized truck mounted loader has proprietary parts and assemblies, and;

**WHEREAS**, the total cost for one (1) specialized truck mounted loader is \$68,876.56, and;

**WHEREAS**, the purchase of eight (8) replacement utility trucks and one (1) specialized truck mounted loader will be fully funded by water, sewer and JEPA, and;

**WHEREAS**, the City Council considered this Resolution at its duly noticed regular meeting on August 26, 2014 along with the staff report.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Rohnert Park that it does hereby authorize and approve the purchase for the aforementioned eight (8) utility trucks and one (1) specialized truck mounted loader from the following authorized vendors at or below the following amounts:


