A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK APPROVING THE NOTICE OF COMPLETION FOR THE EASTSIDE TRUNK SEWER PHASE II AND DIRECTING THE CITY ENGINEER TO FILE THE SAME

WHEREAS; on September 10, 2013, the City Council of the City of Rohnert Park adopted Resolution 2013-128, approving the plans and specifications for the Eastside Trunk Sewer Phase II and Awarding the Contract to Ghilotti Construction Co., Inc. in the amount of \$8,302,825.00; and

WHEREAS, the work generally consisted of the installation of approximately 10,000 linear feet of 18 and 24-inch gravity sanitary sewer pipe and repaving along Avram Avenue, Santa Alicia Drive, Seed Farm Drive and Southwest Boulevard; and

WHEREAS, all work has been completed in accordance with the contract; and the punch-list items have been completed and signed off by the City Engineer; and

WHEREAS, the final contract value of \$8,313,872.46 (an 0.13% increase) is within the City Manager's authority to approve and has been approved by City Manager; and

WHEREAS, filing the Notice of Completion is the final step in the City's process to accept ownership of the project and release retention funds to the contractor.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park hereby approves the Notice of Completion for the Eastside Trunk Sewer Phase II, in substantially similar form to Exhibit A, which is attached to this Resolution and incorporated by this reference.

BE IT FURTHER RESOLVED that the City Engineer is hereby authorized and directed to file the Notice of Completion and to execute documents pertaining to the same for and on behalf of the City of Rohnert Park.
