## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK APPROVING THE NOTICE OF COMPLETION FOR THE INTERCEPTOR OUTFALL GRAVITY SECTION REHABILITATION PROJECT NO. 2011-04 AND DIRECTING THE CITY ENGINEER TO FILE

WHEREAS, on July 22, 2014, the City Council of the City of Rohnert Park adopted Resolution 2014-084, approving the plans and specifications for the Interceptor Outfall Gravity Section Rehabilitation Project No. 2011-04, Awarding the Contract to Michels Corporation in the amount of \$229,565.00 and Finding Such Action Exempt from CEOA; and

WHEREAS, the work generally consisted of lining the terminal 2,300 feet of the City's 24-inch outfall pipeline just upstream of the Laguna Treatment Plant; and

WHEREAS, all work has been completed in accordance with the contract; and the punch-list items have been completed and signed off by the City Engineer; and

WHEREAS, the final contract value of \$230,693.00 (an 0.5% increase) is within the City Manager's authority to approve and has been approved by City Manager; and

WHEREAS, filing the Notice of Completion is the final step in the City's process to accept ownership of the project and release retention funds to the contractor.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park hereby approves the Notice of Completion for the Interceptor Outfall Gravity Section Rehabilitation Project No. 2011-04 in substantially similar form to Exhibit A, which is attached to this Resolution and incorporated by this reference.

BE IT FURTHER RESOLVED that the City Engineer is hereby authorized and directed to file the Notice of Completion and to execute documents pertaining to the same for and on behalf of the City of Rohnert Park.
