

RESOLUTION NO. 2015-051

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK APPROVING THE NOTICE OF COMPLETION FOR THE WILFRED AVENUE IMPROVEMENTS, PROJECT 2010-05 AND DIRECTING THE CITY ENGINEER TO FILE THE NOTICE OF COMPLETION

WHEREAS, on April 9, 2013, the City Council of the City of Rohnert Park adopted Resolution 2013-067, approving the plans and specifications for the Wilfred Avenue Improvements, Project No. 2010-05 and Awarding the Contract to Desilva Gates Construction; and

WHEREAS, the work generally consisted of widening Wilfred Avenue between Redwood Drive and Stony Point Road; and

WHEREAS, all work has been completed in accordance with the contract; and the punch-list items have been completed and signed off by the City Engineer; and

WHEREAS, filing the Notice of Completion is the final step in the City's process to accept ownership of the project and release retention funds to the contractor; and

WHEREAS, the Wilfred Avenue Improvement Project was previously approved by the City pursuant to a Notice of Exemption on September 25, 2012. The City filed a Notice of Exemption with the County Clerk on September 26, 2012, who posted it that same day through October 29, 2012.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park hereby approves the Notice of Completion for the Wilfred Avenue Improvements, Project 2010-05, in substantially similar form to Exhibit A, which is attached to this Resolution and incorporated by this reference.

BE IT FURTHER RESOLVED that the City Engineer is hereby authorized and directed to file the Notice of Completion and to execute documents pertaining to the same for and on behalf of the City of Rohnert Park.
