A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK ACCEPTING THE DOWDELL AVENUE IMPOVEMENTS - PROJECT 2011-11 AND DIRECTING RELATED ACTIONS

WHEREAS, on October 8, 2013, the City Council of the City of Rohnert Park adopted Resolution 2013-138, Authorizing and Approving the Off-Site Public Improvements and Public Facilities Fee Credit Agreement and Termination and Supersession of the Deferred Improvement Agreement by and between the City of Rohnert Park and the Spanos Corporation (the "Agreement"); and

WHEREAS, the Agreement assigned to the Spanos Corporation the duty of installing public improvements, specifically the extension of Dowdell Avenue between Martin Avenue and Business Park Drive in two segments known as the "South Segment" and the "North Segment"; and

WHEREAS, the extension of Dowdell Avenue between Martin Avenue and Business Park Drive is included in the City's Public Facilities Finance Plan and the Agreement describes the Spanos Corporation's eligibility for Public Facilities Fee Credits for the cost of the work up to a maximum amount of \$2,700,248; and

WHEREAS, a portion of the Public Facilities Fee Credit was provided to the Spanos Corporation at the start of the construction project with the remainder due upon successful completion of the both the North and South Segments; and

WHEREAS, Spanos Corporation has completed the construction of both the North and South Segments in accordance with the plans and specifications for the work and has requested the City to accept the work; and

WHEREAS, Spanos Corporation has also submitted documentation of its construction costs and requested release of its remaining Public Facilities Fee Credits; and

WHEREAS, filing the Notice of Completion is the final step in the City's process to accept ownership of the improvements; and

WHEREAS, the extension of Dowdell Avenue between Martin Avenue and Business Park Drive was included within the scope of the Final Environmental Impact Report for the Stadium Lands Planned Developed Area, which was certified by the City Council with June 10, 2008 by Resolution 2008-086.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rohnert Park hereby accepts the Dowdell Avenue Improvements and approves the Notice of Completion, in substantially similar form to Exhibit A, which is attached to this Resolution and incorporated by this reference.

BE IT FURTHER RESOLVED that the City Engineer is hereby authorized and directed to file the Notice of Completion and to execute documents pertaining to the same for and on behalf of the City of Rohnert Park and to complete the review of the Spanos Corporation's documentation and certify the construction costs eligible for Public Facilities Fee Credits.

BE IT FUTHER RESOLVED that upon certification of the City Engineer, the Finance Director is authorized and directed to take the actions necessary to accept the Dowdell Avenue Improvements as a capital asset of the City and release any remaining fee credits up to the cumulative maximum amount of \$2,700,248.
