WHEREAS, on May 27, 2014, the City Council of the City of Rohnert Park adopted Resolution No. 2014-050, approving the plan and specifications for the Rohnert Park Expressway 16-inch Transmission Main, Project 2004-08 and awarding the Contract to Argonaut Constructors, Inc., and

WHEREAS, all work has been completed in accordance with the contract and the punch-list items have been completed and signed off by the City Engineer; and


WHEREAS, filing the Notice of Completion is the final step in the City's process to accept ownership of the project and release retention funds to the contractor.
