**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROHNERT PARK  
APPROVING THE FIRST AMENDMENT TO THE 2014 EMPLOYMENT  
AGREEMENT BETWEEN THE CITY OF ROHNERT PARK AND BRIAN  
MASTERSON FOR DIRECTOR OF PUBLIC SAFETY SERVICES**

**WHEREAS**, on April 1, 2014, the City entered into the 2014 Employment Agreement with Brian Masterson ("Employment Agreement") to retain his services as the Director of Public Safety;

**WHEREAS**, the City and Brian Masterson desire to amend the Employment Agreement to modify the terms and conditions of Brian Masterson's employment as Director of Public Safety to extend the term of the agreement to March 31, 2021;

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Rohnert Park hereby approves the First Amendment to the Employment Agreement between the City of Rohnert Park and Brian Masterson for Director of Public Safety Services in substantially the same form attached hereto as Exhibit "A," which is incorporated herein by this reference.

**BE IT FURTHER RESOLVED** that the City Manager is authorized and directed to execute same for and on behalf of the City of Rohnert Park.

**FIRST AMENDMENT TO 2014  
EMPLOYMENT AGREEMENT**

**Between**

**CITY OF ROHNERT PARK AND BRIAN MASTERSON**

**1. PARTIES AND EFFECTIVE DATE**

The parties to this First Amendment to 2014 Employment Agreement ("Second Amendment") are the City of Rohnert Park ("City") and Brian Masterson ("Employee"). The effective date of this First Amendment shall be March 28, 2017.

**2. PURPOSE**

The 2014 Employment Agreement between City and Brian Masterson dated April 1, 2014 ("Employment Agreement") expires on March 31, 2017 and both parties hereby desire to amend the Employment Agreement as set forth below.

**3. AMENDMENT**

A. Section 2 of the Employment Agreement is hereby modified to read in its entirety as follows:

**2. TERM.**

The term of this Agreement shall be from the 1st day of April, 2014 through the 31<sup>st</sup> day of March, 2021, or until terminated by either party in accordance with the provisions set forth in Paragraph 3 or by the event of the death or permanent disability of Employee.

**4. GENERAL PROVISIONS**

A. This First Amendment consists of pages 1 through 2 inclusive, which constitute the entire understanding and agreement of the parties and supersedes all negotiations or previous agreements between the parties with respect to all or any part of the terms discussed in this First Amendment.

B. Except as specifically modified herein, all remaining terms and obligations set forth in the Employment Agreement between the City of Rohnert Park and Employee shall remain in full force and effect.
